Master in Corporate Communication

Capstone project equivalent to the Master's thesis and set of courses in professional skills

Document derogating from the 2020-2021 Study Regulations of the Faculty of Communication, Culture and Society.

The Faculty Council, at its meeting of 3 June 2020, approved the following in relation to the Master in Corporate Communication: (1) a capstone project equivalent to the writing of a thesis, in derogation from article 15 of the 2020-2021 Study Regulations; and (2) the introduction of a set of courses in professional skills.

This document is applicable to students who enrol in the first year of the Master's programme starting from the 2020-2021 academic year.

Thesis and equivalent capstone projects

This Master's degree offers two alternative methods for concluding the study programme:

- Writing of a Master's thesis, regulated by all the terms and conditions set out in the 2020-21 Study Regulations, as well as the Guidelines for the Writing of the Master's thesis.
- Field project, regulated by the terms and conditions set out in the "Field project guidelines", which entered into force in September 2019.

The Field Project is regulated by the following provisions:

- 1. The Field Project awards a total of 18 ECTS credits.
- 2. The Field Project is only offered to students in their fourth semester.
- 3. Only the students who have acquired at least 39 ECTS credits in the first year of the Master's programme will be entitled to carry out a Field Project.
- 4. For students admitted to the Master's programme with a shortfall in ECTS credits (a maximum of 60 ECTS credits) that opt for the Field Project, the credits allocated to the latter (18 ECTS credits) will only be registered once the shortfall has been recovered.
- The Field Project is assessed using a numerical scale, which forms part of the final average mark. If the Field Project is not completed during the fourth semester, the student must opt to write a Master's thesis.
- 6. The Director of the Master or the person appointed by the latter (field project supervisor) is responsible for the grading of the Field Project, on the basis of the criteria specified in the guidelines. The Field Project requires a report to be written in English. The validation of the Field Project, with the consequent registration of the 18 ECTS credits and the assigned mark, is subject to the passing of all the first and second year Master's examinations, as well



- as having fulfilled the required language conditions (in particular, the achievement of the C1 level of English). The registration of ECTS must take place by the end of the eighth semester starting from enrolment in the Master's program, under penalty of exclusion from the Faculty.
- 7. In the event of any disputes, the decision is made in the first instance by the Director of the Master. The student has the right to lodge an appeal against this decision with the Complaints Commission, according to the provisions of the 2020-2021 Study Regulations.

For all matters not regulated herein, please refer to the 2020-21 Study Regulations, which are applied in accordance with the principle of analogy.

Set of courses in professional skills

To conclude the study programme, this Master's degree also requires students to complete a set of courses in professional skills.

The set of courses in professional skills is regulated by the following provisions:

- 1. The set of courses in professional skills awards a total of 12 ECTS credits.
- 2. This set of courses must be completed by the end of the sixth semester from admission to the Master's programme, under penalty of expulsion of the student from the Faculty.
- 3. Only the students who have acquired at least 39 ECTS credits in the first year of the Master's programme will be entitled to take the set of courses in professional skills.
- 4. The set of courses in professional skills is assessed using a binary grading system (pass/fail), which does not form part of the final average mark. A student who fails an examination in the set of courses in professional skills may attempt it again a maximum of two times. A student who fails to attend an examination or leaves the hall while the examination is in progress without a valid reason is considered to have failed the examination and it is counted among the maximum number of attempts permitted for passing the exam. Failing the examination at three sittings results in the candidate being excluded from the Faculty.
- 5. The lecturer in charge of each course in the set of courses in professional skills is responsible for the grading, on the basis of the parameters described in the respective course syllabus.
- 6. In the event of any disputes, the decision is made in the first instance by the Director of the Master. The student has the right to lodge an appeal against this decision with the Complaints Commission, according to the provisions of the 2020-2021 Study Regulations.
- 7. For all matters not regulated herein, please refer to the 2020-21 Study Regulations, which are applied in accordance with the principle of analogy.
