The two most important documents



1

The Learning Agreement

- It is the **fundamental** document that guarantees the recognition of ECTS obtained during the exchange;
- Its management **depends** on the faculty and study programme;
- All information is contained in the two documents 'Learning Agreement: User Manual' and 'Fields for Learning Agreement', which you are invited to read carefully;
- The study programme coordinators verify the correctness of the Learning Agreement and approve it;
- The Learning Agreement must **always** be kept up to date in Mobility Online.
- **Courses are subject to approval from the host university and acceptance is not guaranteed!**

2

The language certificate

- **Foreign language:** language of study at the host university;
- **Certificate:** only official and internationally recognised certificates (e.g. IELTS, Cambridge, TOEFL, Goethe, etc.) or the USI internal exam are accepted. No other forms of certification are accepted;
- Not all partner universities accept exams taken internally at the student's home institution.
- All information regarding minimum language requirements can be found in the factsheets of the partner universities.
- **It is the students' responsibility to ensure that they meet the minimum requirements (level and type of certificate) set by the host university. Proof of language proficiency, if required, must be provided no later than the internal enrolment deadline.**

The Learning Agreement: insight

- This information is available, in details, in the “Learning Agreement: User Manual”.
- Master students: Master students take elective courses while in exchange. **You do not need to find equivalence with USI courses unless otherwise required by your USI study plan!**

Three key points

1

The Learning Agreement is completed using the digital module directly from your Work Flow in Mobility Online.

2

Any changes must be entered into the digital module and must be submitted for approval to USI to secure ECTS recognition. The final version must be completed no later than one month after the start of the exchange semester.

3

Acceptance into approved courses is not guaranteed. Stay flexible as your LA will most likely change.

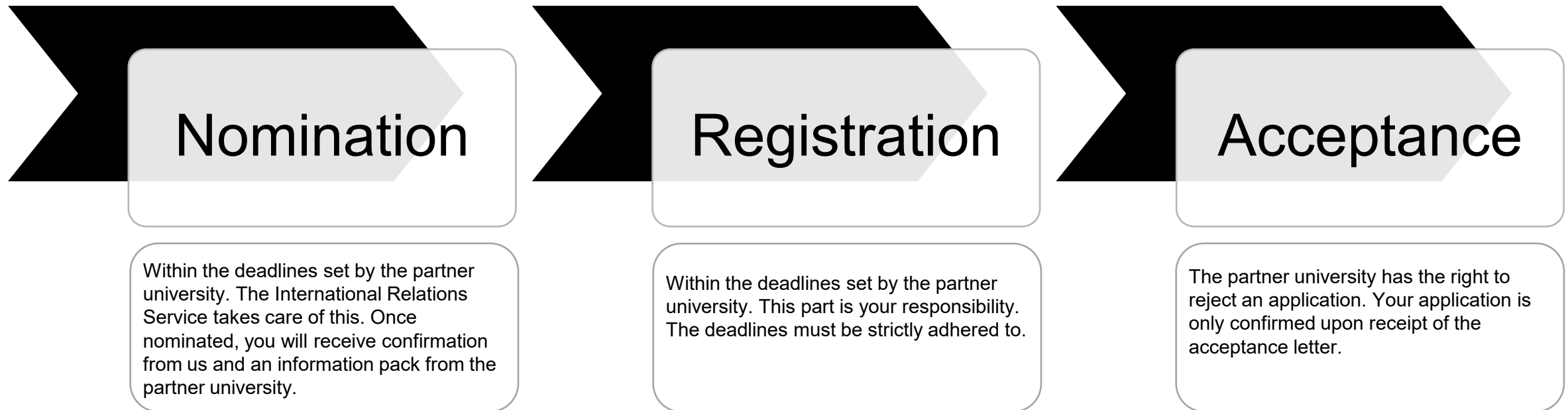

Plan your journey

We recommend that you book your trip only after receiving your letter of acceptance and confirmation from the International Relations Service that all formal requirements as per study regulations have been met.

Departure procedures

Regardless of the destination, it is your responsibility to comply with the procedures required by the cantonal and municipal authorities. USI cannot intervene in or influence the decisions of the cantonal authorities regarding permits and cannot act on behalf of the candidate/applicant.

Health insurance

It is your responsibility to check that your health insurance also covers you in your destination country or, if not, to take out an appropriate policy.

- The course must in any case be approved to ensure recognition of ECTS credits;

- Can I mix different types of mobility when I choose the destinations? **Yes, you can.**
 - Can I take courses both at USI and at the host university? **No, you cannot.**
 - May I take exams at USI during my exchange? **No, you cannot**
 - Do host universities accept the language certificate issued by USI? **Not all of them (factsheets).**
 - Am I eligible for the SEMP scholarship if I do an exchange in my residence country? **No.**
 - Can I skip the Orientation programmes at the host university, or arrive there after the beginning of classes? **No, many universities have mandatory orientation programmes for incoming students.**
 - What happens if I fail an exam at the host university? **You may catch it up at the next exam session, should the host university offer this possibility or you compensate it with a course at USI once you are back.**

- Is there a minimum or maximum number of ECTS that I can obtain during my mobility period? **In general, the workload should correspond to a full semester (30 ECTS). However, students are free to take as many ECTS as their study plan requires. Please keep in mind, that certain universities require a minimum number of ECTS, for example:**
 - **University of St. Gallen: minimum 16 ECTS**
 - **ETH Zürich: minimum 20 ECTS**
 - **EPF Lausanne: minimum 20 ECTS**
- **This means, that students are required to attend courses and take exams for that minimum workload. Registering to exams for less than the minimum workload is not accepted.**

How to read our course codes? Is the course of Bachelor or Master level?

Every course has a unique code, e.g. JEB111, where the **third letter states the level of the course.**

B - bachelor level,
M - master level,
D - doctoral level

RULES

- Students can register for courses of **max 36 ECTS per semester.**
 The minimum for bachelor-level students is 20 ECTS
The minimum for master-level students is 15 ECTS
- More than **51%** of the registered courses **MUST** be from the hosting faculty.
- Student can visit **only 1 sports course** and it must be in the Learning Agreement.
