
Provisions for the Winter 2022 Examinations Session of the Academic year 2021-2022

Approved by the USI Rectorate on 13.01.2022

Note: this document is translated into English for reference purposes only. For all legal issues the original Italian text shall be referred to.

Context

Due to the ongoing uncertainty caused by the Coronavirus, USI considers it appropriate to take some extraordinary measures for the ordinary winter 2022 exam session of the 2021-2022 academic year. These decisions are made to protect the students' interest in the best possible way, prevent them from being penalised from the current situation, and ensure a serene environment within the University.

In the text, nouns declined in the masculine or masculine plural are also inclusive of the feminine or feminine plural.

Examination modalities

1. As a rule, exams of the ordinary winter session 2022 are carried out in attendance, according to the modalities provided by the Study Regulations of each Faculty.
2. In compliance with federal regulations, a certificate of vaccination, recovery or test (the so-called "3G") must be presented upon entering the classrooms to attend the exams; this certificate will be checked systematically by the exam supervisors.

Absence

1. A doctor's note is required for all absences due to illness. In addition, students who are unable to attend one or more exam sessions because of Covid-related symptoms, have tested positive on a molecular test (PCR test) or a rapid antigen test for covid-19, or are in isolation or quarantine may also be considered excused absentees. "Home-tests" tests are not valid.

2. Students who report an absence for the reasons listed above must fill out a self-certification form with supporting documentation. The self-certification must contain the information required on the form attached to this Directive.
3. The procedure is as follows: the student reports as soon as possible, in any case before the beginning of the exam, his absence for one of the reasons listed above. Such notification can be made through the self-declaration form or a simple email. Then, within 10 days from the exam date, the student is required to submit the self-declaration duly completed.
4. Absences excused in this way will not be counted as fail and therefore will not affect the number of attempts available to take or retake the exams.

Final arrangements

1. These Provisions are confirmed and notified:
 - To all students on the iCorsi platform and through the Students Service Office.
 - To all faculty members according to modalities defined by the single Faculties;
 - To the administrative staff involved through the Students Service Office;
 - To the university community as a whole through institutional communication channels.
2. Any exceptions and waivers are the competence of the Pro-Rector for Education and Students' experience after conferring with the relevant Faculty.
3. Any additional sessions that may be required due to the impact of the pandemic will be defined by the Pro-Rector for Education and Students' experience, in agreement with the Faculties.
4. Any complaints and appeals shall be governed in accordance with the Study Regulations of each Faculty.
5. These Provisions supersede for the ordinary winter 2022 examination session any conflicting provisions contained in other legal bases.
